

EDITORIAL

USPA HEADQUARTERS MOVE (AGAIN)

Once again the question of moving USPA headquarters is being studied. The facts are simply that the present location on Cannery Row in Monterey is too small; not just smaller than we would like, but too small to operate efficiently. Mike Linz's recent headquarters study revealed that at the present growth rate, the operation will expand beyond the capability of the facilities by spring of 1973. We now pay \$5,000 per year for 2,200 sq. ft. of fire trap to run a \$213,000 corporation for 15,000 members.

One basic question is should we rent or build. At \$5,000 per year we are far better off owning our own plant than being subject to the whim of a landlord. In a move, we have three basic choices: 1. Find another spot in Monterey 2. Move to Washington D.C. 3. Move elsewhere. Washington is where the FAA, Government, lives and it would be nice to locate closeby. But labor and space in this area is very expensive. Washington is as close as the telephone and the USPA doesn't have to locate there any more than the Soaring Society, the Balloon Federation or the Experimental Aircraft Assn. Bill Ottley and Len Potts are close by and they keep a parachuting ear to the ground.

A distant move requires training of new personnel and a break in membership services. The girls in the office are tied to Monterey and Norm Heaton says that he, Rouillard, and Curtis won't leave the area. (Would you?) This means a whole new staff, starting all over.

Jim West has generously agreed to donate land adjacent to his Greene County operation in Ohio and Tahlequah has made a proposal. But the Headquarters should not be located at a jump center; there are toomany people dropping in to visit now and the staff have become "tour directors."

Jack Bergman is working on plans and Ray Starnes has drawn up some proposals. Bergman says: "The Headquarters move is second in priority only to our FAA legal problem."

We need space for current work load, for expansion, a library and a parachuting museum. The rent could better be spent for our own land and building. Relocation yes, but in the Monterey area and let's keep our valuable, knowledgeable staff. Let's not start over.

The Headquarters has moved within Monterey three times in the last ten years and you didn't even notice.

HEATON - HARDMAN TO WED IN MONTEREY

Kay Hardman, CSPA Director and famed Canadian parachutist from B C and more recently Ontario will tie the knot with USPA Executive Director Norm Heaton. Kay made the announcement at the CSPA Board meeting in Vancouver on 2 July as she submitted her resignation to the Board. She then went on to finish second in accuracy, style and overall in the Canadian Nationals in Abbottsford. Sources close to Heaton knew something was up because he had told his long time roommate Earl Waggoner that he had until the end of the month to move out. Heaton has been with the USPA since 1964.

FAA is about to push through the "column of air" concept which could end all legal parachuting in the U.S. Under the proposal each drop zone would have to make application for a column of air which the ATC might allow for a period of up to 12 months. Additionally, pilots would have to secure authorization to release their jumpers; only notification is required now.

The effect of the first proposal will be the eventual elimination of all drop zones as the "licensing" of these columns of air is left up to the bureaucratic FAA and the FAA is controlled by the airlines. The second will mean a sharp increase in jump rates since ATC will be able to put a hold on jumping for an indefinite period; the jump aircraft will orbit increasing tach time.

Bill Ottley found out bout the plot in April and quickly laid hands on the proposal and forwarded it to USPA Headquarters. A meeting with the FAA was arranged in early May and Norm Heaton flew to Washington to join Ottley and Len Potts. The FAA representatives were very surprised that the parachutists had a copy of the proposed notice and indicated that the purpose was not to hinder the condust or growth of sport parachuting. It was also clarified that the action was started by the Air Transport Association (airlines) and that the columns of air concept originated in the Northeast. Orange has an agreement for a column with Boston Center; the DZ is marked right on the scope. The famed Mecca of sport parachuting is right on Victor 2 and jets making an approach to Boston's Logan airport cross over the bowl at about 8,000 feet. Concern has been voiced by the airlines for the parachuting activity at Chicago-Hammond, home of the Golden Puppets but they did not figure in this particular FAA notice proposal.

At the Washington meeting, USPA was assured that the notice would be dropped and, in fact it did not come up at the FAA's notice meeting the following day. A few days later, however, the matter was turned over to FAA's Flight Standards Service and given new life. The Notice of Proposed Rule Making should be published any day now.

The problem was discussed in great detail in Tahlequah at both the General Membership Meeting and the Board of Director's meeting. Norm Heaton stated that the "columns of air concept is completely out of line" and that our position should be "that we should be able to use any airspace as long as we don't interfere with other users." He went on to say: "The current regulations are sufficient to allow us our fair share of the air space." A plan of attack was generally agreed upon; USPA will quit the "low Profile" approach and will take a firm stand by making some proposals itself. As soon as the Notice is published by the FAA, an overwhelming letter writing campaign will beinitiated. Then the letters will be turned to Congress demanding that the FAA justify its actions. USPA will provide the membership with a list of congressmen, their committee positions, addresses and tips on letter writing. USPA has already written FAA, retained legal council, and given Scott Hamilton and Airspace Reserach Grant.

Part 105 was last re-written in 1967, a greatly watered down version of the original proposal. The response from the parachutists was second only to the time it was proposed to ban liquor from the airlines. The hearing room overflowed into the halls and the meeting was covered by many newspapers and TV. USPA's arguments were so strong that the ATA, ALPA, etc., did not show up to rebutt them after lunch. It cost the USPA a lot of time and money but it was worth it - we're still jumping. Bill Ottley warns, however, "The FAA rarely drops an item, they usually compromise. The best we can do now is to get a modification of the column idea."

PEPPERELL'S TWIN OTTER A TREMENDOUS SUCCESS

Eight mens are now being produced over the Northeast as participants gain proficiency. As many as 16 jumpers exit on one pass as Executive Airlines Captain Mark Schmidt (D-21) brings the Otter over the DZ just 15 short minutes after tak off. Teams showed up from all over on the Fourth of July weekend and over 30 flights were made. Already scheduled for 7 and 8 August and 18 and 19 September, the Otter will also return on 2 and 3 October, 23-24 October and 13-14 November. The last date will feature the Second Annual East Coast Fight Man Star Meet; the first was at Stormville last September.

Each dropzone is encouraged to start its own team spending the greatest energy on building a good base. Picking up fliers is easy but they're wasting their time if the base fails to materialize.

Farning their star crests on the last Otter visit were: Don Mayer, Norm Fraser, B J Worth and Fred Hoffman.

The Otter leaves Boston's Logan Airport at 8:00 on Saturday morning for the jumpin ferry flight to Pepperell and returns Sunday evening. Visitors who fly into Boston may catch this flight out.

The last Otter weekend was highlighted with the visit of Californians Bill Smith and Mike Blodgett.

"USPA, as a maturing organization, needs an opportunity (separate from the pressure-cooker of national competition) to get together, to learn, to trade -and horse trade; and to introduce USPA to top FAA officials, distinguished guests from Government and the aviation world. The object: first and foremost -- fun, salted with important business and the opportunity to learn what's new and hone up on existing skils."

WINDSON THIS IS ANOTHER FANTASTIC ISSUE OF THE SPOTTER

Gary Patmor's computerized scoring system was the single most important improvement at this year's nationals. Actually, the computer played an almost minor role, Patmor's display of scores was the biggest gain.

The scoring system consists of 1) color-coded and stagered judges forms for style and relative work, 2) a computerized scoring system that quickly and accurately compiles the scores and ranks the contestants in each round, each event and combination points after each round, and 3) a series of score boards. The score boards display 1) the scores, 2) the judges summary sheets for style and relative work, 3) the ranking in each round, each event and combination after each round, and 4) displays graphically the current status in accuracy, style, relative work and combination.

Minor difficulties encountered at the Nationals have been worked out and a review and rewriting of the system will be made on 1 August. The cost for computer time during the Nationals was less than \$300.

FAA PUSHING TRAFFIC PATTERN PROPOSAL Seen as threat to jump operations

FAA soon may publish a Notice of Proposed Rule Making which will require standard "racetrack" patterns at all airports. This would prohibit straight in approaches, two way use of a runway, etc. The extra time in the pattern would mean increased costs and higher jump rates.

In a memo to the USPA Board dated 15 June, Bill Ottley suggested that the USPA join the National Pilots Assn and the Aircraft Owners and Pilots Assn in recommending that the racetrack pattern be required only at "public use" airports. Ottley went on to say:

"This would allow jump operators working off their own strips. or off small and otherwise lightly-used strips, to arrange to have them marked "R" on the charts; and then operate any way they want. (Declaring an airport "restricted" does not

in any way limit who may land and take off, unless the owner so states.)

Jump operators at larger airports (any place where the airport operator was unwilling to declare his field restricted) will (a) fly the standard circular pattern and use the designated preferred runway; or (b) apply to the FAM for a waiver from the rule (which according to my information is likely to be fairly hard to come by)."

PI FINALLY GETS TWIN BEECH

Heightened interest in relative work — and competition from other DZs — has finally pressed Parachutes Incorporated into leasing a Twin Beech for use by its Orange and Lakewood Centers. The shiny white Beech supposedly will be shared equally by the two centers, and will not be at Orange on those weekends that the Twin Otter is at Pepperell. Orange is seeking to develop a star team to compete with the Lakewood one and Pepperell's "Pieces of Hight", which have become fairly proficient at putting together eight mans.

TURNERS FALLS GETS NEW OWNER

Bob Elliot has bought the Turners Falls, Mass., jump operation from long-time owner and ASO Jesse James, while Jesse has taken over the fixed base operation at the airport. So far Elliot has remodeled the office-packing shed-dormitory quarters, has put a red carpet in the Cessna, has put in a new pea gravel DZ -- and has installed a new system of jump tickets, something Turners never had before.

NOPTULAST CONTERENCE DIRECTOR'S REPORT by Dan Poynter

While most of the activities of the USPA, Council and the Northeast Conference Director are noted elsewhere in these pages, listed below are some of the special items which received attention since the last issue.

Miles driven: 7150 Letters written: 114

Since the last issue, I have visited DZs at Turners Falls, Orance and Pepperell, Mass, Fulton and Akron, NY, Bardstown, KY and Tahlequah, Oklahoma. In Tahlequah I attended the Board and General Membership meetings and served as Equipment Inspector and as a member of the Jury. With the help of the Safety and Training Committee, I rewrote most of the USPA Doctrine and redrafted USPA's Flotation gear specification. Despite all the paperwork and road miles, I have managed to make quite a number of jumps including over 30 from the Twin Otter. The weather seems to be taking a turn for the better, it certainly couldn't get any worse.

CARVILLE JUMPS A THUNDERBOW OR "THUNDER. SON OF CROSS"

Ken Carville finally got to jump a Thunderbow canopy at Pepperell July 5 after an embarassing false start a couple of weeks earlier at Turners Falls.

The earlier attempt occurred when Grant Spaulding arrived at Turners and Ken, knowing Grant's affection for Crossbow canopies, lept to the assumption that he had bought a Thunderbow.

When Kenny asked Grant if he might jump the canopy, Grant did nothing to dissuade him. It wasn't until after he pulled the ripcord that Carville became suspicious. "It didn't look like thepictures. There was no point in the front," said Carville later. (He was also backing up faster than the PCs in the air with him.) It was not, however, until he reached the ground and someone showed him the canopy's data panel that Carville fully realized what he had done — jumped one of Grant's custom made Crossbows.

(Carville threatened retaliation against the SPOTTER if it printed this story unless it presented his side of the story, which has something to do with his beating Grant out of the cost of the jump.)

ASO HANDBOOK HAS NEW CUSTODIAN

The USPA Area Safety Officer Handbook project, which has passed through more hands than a dirty magazine in a dormitory, is now in the custody of Howard White, northeastern Massachusetts ASO, who acquired it from Don Grant. Grant has his hands full with various USPA training publications and didn't have time to work on the ASO handbook — a bulky file that has been gathering memoes and documents since at least 1964.

White intends to prepare a request to be circulated with the ASO/Instructor Bulletin for suggestions on what should be included in the handbook and for help in resolving some of the knottier questions on such things as ASO's enforcement powers.

INCIDENT REPORT - ACCIDENTAL RESERVE DEPLOYMENT BY Robert Chad LeBeau

Archway Para-Center in Sparta, Illinois had a jumpmaster reserve deployment in the 182 jump plane on Saturday, 12 June. The incident occured while jumpmaster Rick Quads (275 jumps) was putting out his girl on a static line jump. Rick was pulled from the 182 doing \$3,800 damage to the door frame. Pick was only bruised and a bit shaken up. The pilot landed the plane without any trouble. The main cause of the accidental deployment was that the static line was hooked up under the back seat and instead of running under the jumpmasters feet it was routed over and across him. Once the student left the strut, the static linewas pulled down on the reserve ripcord opening the 26' reserve. The reserve deployed so fast Rick was not aware of it till almost all the lines were out. The reserve had one Time cut by the ragged door frame. Rick said at first he thought that the student's sleeve was hung on the static line. The one factor that saved Rick from being pulled through the side of the plane was that he was sitting well forward and in the doorway so he was pulled out and not through. Rick's girl landed closer to the target winning their accuracy bet.

THE PCA IS FALLING by Chicken Little (Aka: Jim Carter)

As mentioned in PARACHUTIST, AVIATION WEEK AND SPACE TECHNOLOGY and elsewhere, the FAA is busy making things more difficult for jumpers again, by jerking the floor of the Positive Control Area (PCA) down closer to the ground.

What's a PCA? It's a nationwide layer of airspace that your plane can't fly into

unless the following conditions are satisfied (see FAR 91.33 and 91.97):

1. The plane has to have a transponder, plus all other equipment required for instrument flight. The required items include a full gyro panel, 360 channel transceiver, clock, generator and calibrated altimeter all in working condition.

2. A pilot with an instrument rating is required.

3. Prior to every lift, the pilot has to file an instrument flight plan and get an ATC clearance to fly into the PCA. The usual practice for cross-country instrument flights is to phone the nearest FAA flight service station to give them the flight plan, and then receive the clearance on the aircraft radio after a 30 minute wait. These requirements would put out of business a major portion of the jump crafts and pilots presently flying.

Untilnow the PCA wasn't of much concern to jumpers because its floor was at 24,000 ft. (18,000 ft over the northeastern U.S.) and it extended upward from there. Now, however, the floor of the PCA is falling lower and lower and soon we won't be able to make a delay longer than a 45 without the difficulties mentioned above.

The FAA has announced the following schedule for lowering the PCA:

Already - Lowered to 18,000 ft MSL in the Maine-Virginia-Missouri-Minnesta quadrangle plus the Dakotas, Montana, Idaho Panhandle, Washington and Oregon.

By October 1971 - Lowered to 18,000 ft MSL over the remainder of the continental

U.S. Continued

Later - Lowered to 14,500 ft MSL (that's 9500 ft over Denver) over the 48 states, and even lower to 10,000 ft MSL in the Northeast and between San Francisco and Los Angeles; and down to 6,000 ft MSL under certain airways between Boston, New York, and Washington.

Parachuting probably won't be materially affected until the PCA drops below 15,000'.

THE FULTON (NEW YORK) \$3,500 MONEY MEET, JUNE 5-6, 1971 by George McCullock

When is a guaranteed meet? Out in Michigan, Tecumseh's promoters clearly committed. themselves to a \$2,200 bankroll in their advance publicity. Not so Smitty's \$3,500 meet at the Fulton (N.Y.) Sport Parachute Center, the weekend following. So jumpers who otherwise might have moved on from Michigan to Central New York, lured by the biggest prize money on the calendar, stayed away in droves.

Result was that only 55 contestants showed up for the Fulton event on June 5. Smitty (Willard J. Smith on his license) needed more than 100 to break even on his

brash promise.

However, as far as Smitty was conerened, the meet was guaranteed. He had told some folks this, even if the published billing didn't say so. He had promised \$2,500 prize money for the accuracy event, hadn't he? But the "take" from the 50-odd entrants didn't even cover the prizes, not to mention "tach-time" and the stack of other bills.

During the day, as one jumper after another plowed into the 10-meter circle, Smitty raided his meager bank account down to the last 68 cents, pooled his cash and his checks, and counted them out. When the last load of jumpers had stamped the defenseless disc into the peas, the winners assembled, expecting to collect maybe two bits on the buck. But Smitty was there with a crumpled envelope, and every man of the promised "I thru 25" walked away with his money - Dave Sauve: \$300 for first place, \$100 for second thru 20th, \$60 for 21st thru 25th. Smitty, insolvent but game at the day's end, had his big moment when he piloted his red P C into the peas for his 1,000th free fall, with conference director Dan Poynter on hand as observer. The solid circle of men and gals who ringed the DZ moved in on Bill and doused him with beer in a general melee. The word gets around. Next year, whatever the advance notices say or fail to say, a lot of jumpers will converge on Fulton, confident that Smitty will pay off.

UNITED STATES TO HOST 1972 WORLD MEET

The FAI has awarded the XI World Parachuting Chapionships to the U.S.; Tahlequah. Oklahoma is the likely site for the September 1972 meet. On 28 June, the Board of the Tahlequah Chamber of Commerce voted to host the World Meet if FAI approval could be secured. Later David Hall, Governor of Oklahoma and Bill Willis, Chairman of the Appropriations committee of the State Legislature pledged \$50,000. in state funds to get the ball rolling. On 30 June , C.E. Hennecart, Director General of the FAI in Paris, wired all national aero clubs and members of the International Parachuting Commission notifying them that the US bid had been accepted.

The quick acceptance of the US bid and the late decision as to the site was due to the on again-off again bids by other countries and a decision at the 3 March CIP meeting in Paris to accept the US bid if it could be firmed up.

Tahlequah was the site of the '66, '67 and '71 Nationals and sports one of the finest jump sites ever put together. The last World Meet to be hosted by the U.S. YOU AD IN I'S SPOTTER was in Orange, Mass. in 1962.
